Our process **now takes 4 days to enter everything in** and I've actually been able to hire a part-time person and she processes all the utility bills. It allows me to oversee the process and focus more on analysis. I've been able to take more job responsibilities within the department and it's been great for us not to have so much manual entry and human error."
